### **THE INDIAN PARTNERSHIP ACT, 1932**

CHAPTER I PRELIMINARY 1. Short title, extent and commencement.—(1) This Act may be called the Indian Partnership Act, 1932. 1[(2) It extends to the whole of India 2[3\*\*\*].] (3) It shall come into force on the 1st day of October, 1932, except section 69, which shall come into force on the 1st day of October, 1933. 2.
