On April 7, 1986 the Supreme Judicial Court ordered,

inter alia, that: "The time standards set forth below for the trial, settlement or other disposition of civil cases are hereby adopted applicable to cases entered in any department of the Trial Court on or after July 1, 1988: CIVIL CASES OTHER THAN FAMILY LAW CASES, Superior Court, District Court, and Boston Municipal Court, all jury and non ...
